- 2. Guizhou Power Vocational Technical College, principal office at No. 25, Dongtan Lane, Guanshui Road, Guiyang City, Guizhou, the People's Republic of China, hereinafter referred to as Guizhou Power Vocational Technical College and represented in this instrument by its Director, Liang Yan.
- 3. State Polytechnic of Sriwijaya, principal office at Jl. Srijaya Negara, Bukit Besar (30139), South Sumatera, Indonesia, hereinafter referred to as POLSRI and represented in this instrument by its Director, RD. Kusumanto, ST., MM.

In consideration of the above premises and covenants here under provided, all parties to this Letter of Intent (LoI) agree as follows:

- 1. To collaborate in undertaking programs, projects, and other related activities whenever and wherever feasible opportunities present themselves.
- 2. To exchange scientific materials, publications, and information.
- 3. To visit respective partner institutions.
- 4. To exchange lecturer/ teacher.
- 5. To exchange students.
- 6. To collaborate in programs e.g. camp, workshop training, and seminar.
- 7. To execute separate agreements in writing for any particular undertaking jointly implemented, wherein sharing of responsibilities shall be specified and approved by all parties.

This Letter of Intent takes effect upon signing by the authorized representatives of all institutions, and remains in force for a period of 3 (three) years, subject to amendment at any time by mutual consent. The said agreement shall be extended for an additional period of 3 (three) years at each expiration date, unless either party gives written notice to terminate the agreement at least six months prior to the expiration date.
